The Campaign against Established Knowledge and Why it Matters Second Edition



Building on his successful first edition, Tom Nichols confirms his thesis that recent events, such as the COVID-19 pandemic, prove that the assault on expertise has only intensified.

This second edition addresses how technology and increasing levels of education have exposed people to more information than ever before, but have also helped to fuel a surge in narcissistic and misguided intellectual egalitarianism that has crippled informed debates on any number of issues. Nichols highlights how the increasingly democratic dissemination of information, rather than producing an educated public, has instead created an army of ill-informed and angry citizens who denounce intellectual achievement, bringing democratic institutions in danger of falling either to populism or to technocracy or, in the worst case, a combination of both.

- A fully updated indictment of the many forces continuing to undermine the authority of experts, with a new chapter on the COVID-19 pandemic.
- Ties the rise of anti-expertise sentiment and anti-intellectualism not only to the pervasiveness of the internet, but to the rise in populism and conspiratorial thinking.





A History of Byzantium

ANTHONY KALDELLIS, Professor of Classics, University of Chicago

The New Roman Empire is a major history of the eastern Roman Empire, from Constantine to 1453, covering political and military history as well as all the major changes in religion, society, demography, and economy.

Beginning with the foundation of Constantinople in 324 AD, and ending with the fall of the empire to the Ottoman Turks in the fifteenth century, this book incorporates new findings, explains recent interpretive models, and presents well-known historical characters and events in a new light, showing how Byzantium was a vigorous state of its own and a vital node in the first truly globalised world.
